Exclusion - Demolition

Clause 7 - Exclusions to insured section B, C, D and E

The following clause is added to clause 7 of this **policy**.

Insured sections B, C, D and E exclude and do not cover the **insured** in respect of any liability arising out of or from:

- a) the demolition of any structure by a method designed and/or intended to demolish the structure in one sudden and uninterrupted process, including a single action involving the removal of support at ground level;
- b) the use of a swing or drop ball;
- c) use of explosives;
- d) burning of debris.

Exclusion - Heat work away

Clause 7 - Exclusions to insured section B, C, D and E

Clause 8.4 is deleted and the following clause is added to clause 7 of this **policy**.

Insured sections B, C, D and E exclude and do not cover the **insured** in respect of any liability arising out of or in any way connected with the use or application of heat away from the **premises** of the **insured**.

The following clause is added to clause 7 of this **policy**.

Insured sections B, C, D and E exclude and do not cover the **insured** in respect of any liability arising out of or in any way connected with manual work away from the **premises** of the **insured** other than the taking of samples.

WSTWST010109-BC**Condition - Waste conditions****Clause 8 - Conditions precedent to insured sections B, C, D and E**

The following clause is added to clause 8 of this **policy**.

It is a condition precedent to liability that the **insured** takes or arranges that all waste is taken only to licensed sites and that such waste is transported only by licensed carriers.

WSTBFS010109-BC**Condition - Bona fide subcontractors insurance check****Clause 8 - Conditions precedent to insured sections B, C D and E**

Clause 8.1 is deleted and replaced with the following:

8.1 Bona fide subcontractors insurance check

It is a condition precedent to the **insurer's** liability under this insurance that whenever work is undertaken on behalf of the **insured** by bona fide subcontractors the **insured** will establish and maintain an administrative procedure for obtaining evidence that bona fide subcontractors effect public liability insurance that:

- 8.1.1 covers the work to be undertaken by the bona fide subcontractor,
- 8.1.2 is subject to a **limit of indemnity** of not less than GBP2,000,000
- 8.1.3 includes an 'indemnity to principals' clause,
- 8.1.4 the insurance is revalidated every twelve (12) months throughout the duration of their contract with the **insured**.
